## **REGULATIONS OF "KWADRATOWA"**

## THE ACADEMIC CLUB OF GDAŃSK UNIVERSITY OF TECHNOLOGY

- 1. These regulations define the rules for using the "KWADRATOWA" Academic Club of Gdańsk University of Technology (hereinafter referred to as AC KWADRATOWA).
- 2. AC KWADRATOWA operates within the Student Affairs Office, which is an organizational unit of Gdańsk University of Technology and is located in the Bratniak building at 4 Siedlicka Street in Gdańsk.
- 3. The facility is intended for organizing cultural events that are not subject to the provisions of the Act on the Safety of Mass Events.
- 4. The AC KWADRATOWA offer is primarily addressed to students, graduates or employees of Gdańsk University of Technology and students of other universities.
- 5. The organizer of events at AC KWADRATOWA is Gdańsk University of Technology or an entity indicated by it.
- 6. Only adults have the right to enter AC KWADRATOWA. The events indicated by the Organizer may be entered by minors in the presence of a parent or legal guardian.
- 7. The following people are not allowed to events organized by AC KWADRATOWA:
- a) persons who are intoxicated or after consuming alcohol or other intoxicants, legal highs, other narcotic substances, psychotropic substances,
- b) persons under the age of eighteen, subject to point 4, second sentence,
- c) people who will come to the event in a sports outfit, unless the nature of the event allows for such a possibility (e.g. kitsch party)
- d) persons who do not comply with the instructions of the AC KWADRATOWA organizational services (e.g. by refusing to leave outerwear in the cloakroom).
- 8. In the event of inappropriate or aggressive behavior, the Organizer may refuse the right of entry.
- 9. At the entrances to the AC KWADRATOWA premises, event participants are obliged to undergo a document control at the request of an authorized representative of the Organizer. The basis for participation in events taking place in the Club is the presentation of a valid photo ID (student ID, ID card, driving license, school ID, etc.)
- 10. AC KWADRATOWA reserves the right not to let a person into the club without giving a reason.
- 11. The security of the event participants is supervised by the Organizer's Security Service.
- 12. Participants are obliged to strictly comply with the indications and instructions of the security services of the event organizer and persons responsible for the event.
- 13. It is forbidden to bring to the Event Venue or possess during the Event:
- a) weapons or other dangerous items, explosives, pyrotechnic products, fire hazardous materials, alcoholic beverages, narcotic drugs or psychotropic substances, excluding alcoholic beverages purchased on the premises of AC KWADRATOWA;
- b) any professional image or sound recording devices, laser pointers;
- c) any objects or devices that may be used to jam or drown out the course of the Event or in any other way prevent or hinder the efficient conduct of the Event;
- d) any heavy, metal, sharp, glass, hard or other objects that may pose a threat to the Participant trying to bring them in or other Participants, as well as clothing, footwear, bags or backpacks that contain hard or heavy elements that may cause damage to the health of another Participant as a result of a sudden or unexpected contact with their body;
- e) flags, banners or boards that are not directly related to the Event or exceed the size of 4m2 or other items that may prevent or hinder full participation in the Event for other Participants or pose a threat of health damage to them. The flags and banners allowed by the Organizer should be rolled up and the boards removed, at each request of the Organizer or persons authorized by them;
- f) drinks or food purchased outside the Event Venue;
- g) animals.
- 14. The Organizer's security services are entitled to check whether a given person does not bring prohibited items.
- 15. In the event of questioning the items referred to in point 13 when bringing them to the club premises, they will be collected by the Security Services and handed over to the authorized bodies.
- 16. Participants of events are obliged to behave in a way that does not endanger the safety of other people.
- 17. In addition, it is prohibited to:
- a) enter areas that are not intended for event participants,
- b) throw any objects,
- c) sell, advertise, solicit, conduct fundraisers without the organizer's consent,
- d) enter the club room in outerwear (cloakroom is obligatory),
- e) smoke tobacco products outside designated areas,
- f) leave the club with drinks in glass containers,

- g) photograph and do audio-visual recording of the event without the Organizer's consent,
- h) enter the event area with self-catering and drinks,
- i) apply stickers, paint on the walls and destroy property located on the premises of the club.
- 18. Each time you leave the premises (with a few exceptions), the ticket expires, re-entering the club requires the purchase of a new admission ticket.
- 19. The Club is not responsible for items left on the premises of AC KWADRATOWA.
- 20. The rules for using the AC KWADRATOWA cloakroom are set out in the Regulations of the Academic Club of Gdańsk University of Technology "KWADRATOWA". The cloakroom regulations are available on the website www.kwadratowa.pl and at the entrance to the club.
- 21. Persons who do not comply with the provisions of the above regulations and do not comply with the instructions of the Security and Information Services will be removed from the event area, without refund for the previously purchased ticket, and in the case of gross offenses handed over to the competent authorities.
- 22. Entering the club area means automatic and absolute acceptance of these regulations and the participant undertakes to comply with them.
- 23. In the event of disputes not covered by these regulations, the decision, in such a situation, is made by the Organizer of the event or another person authorized by the Club.
- 24. People participating in the event agree to the free dissemination of their image, registered during the event by AC KWADRATOWA for marketing purposes. The consent is granted for an indefinite period and without territorial restrictions. The consent also covers the dissemination of the image by third parties as part of the broadcasting and public playback of marketing materials, reports and materials regarding the event.
- 25. Objections to the activities of AC KWADRATOWA should be addressed in writing to the head of the Student Affairs Office of Gdańsk University of Technology. In justified cases, the case will be referred to the Vice-Rector for Education of Gdańsk University of Technology.
- 26. If, due to the epidemic situation, it is necessary to introduce new procedures or internal regulations, including those containing restrictions, orders or bans, or updates to the existing ones, aimed at preventing infection or the spread of infectious diseases and increasing security, they shall apply from the date indicated therein, and the Participant of the Event undertakes to apply them unconditionally. If the provisions of these Regulations are in conflict with the introduced regulations, internal regulations and procedures in force at Gdańsk University of Technology will prevail over the provisions of the Regulations.
- 27. Participants of the event enter the premises of AC KWADRATOWA at their own risk and responsibility. The administrator of AC KWADRATOWA is not responsible for damage to objects and loss of health or life resulting from the actions of third parties.
- 28. Persons remaining on the premises of the Facility are responsible for the consequences of their actions in accordance with applicable statutory regulations.
- 29. The person who caused the damage is financially liable for the damage caused.
- 30. The manager of AC KWADRATOWA should be immediately notified of any accidents or material damage.
- 31. The Participant of the Event may be exposed to the influence of light stimuli or to being constantly in the area of sound intensity, which may cause damage. The Participant of the Event decides to participate in the Event at their own risk and will not make any claims against the Organizer or Gdańsk University of Technology in this respect.

- 33. These Regulations come into force on 25 October 2021.
