

**RULES OF THE CLOAKROOM OF THE "KWADRATOWA"  
ACADEMIC CLUB OF GDAŃSK UNIVERSITY OF TECHNOLOGY**

1. These Regulations define the rules for using the cloakroom of the Academic Club of Gdańsk University of Technology "KWADRATOWA" (hereinafter AC KWADRATOWA) located in the Bratniak building at 4 Siedlicka Street in Gdańsk.
2. The cloakroom serves people remaining on the premises of AC KWADRATOWA.
3. The use of the cloakroom is allowed during the hours of organized events.
4. Only outerwear is stored in the cloakroom.
5. Leaving outerwear in the cloakroom is mandatory.
6. The cloakroom in the club during regular events is free of charge.
7. Clothing should be collected no later than 2 weeks from the date of the event.
8. The outer clothing left in the cloakroom is issued only on the basis of the cloakroom token.
9. Clothing left in the cloakroom that will not be picked up on the day of the event is stored for a period of 2 weeks. After this period, it is disposed of.
10. The loss or destruction of the cloakroom token should be immediately reported to the staff of AC KWADRATOWA.
11. The fee for losing or destroying a cloakroom token is PLN 20 and is payable at the club's ticket office during the event or at the club's office (Monday to Friday, 9:00-14:00) within 2 weeks, in accordance with section 9 of these Regulations.
12. In the event of loss of items left on a hanger in the Club's Cloakroom due to the fault of an employee of the Cloakroom and when the club guest provides the token assigned, the club guest is entitled to compensation in the amount of the value of the lost items, not higher than PLN 400.
13. In a situation where a club guest loses or destroys the token, Gdańsk University of Technology is not responsible for the loss of items left in the cloakroom.
14. Issuance of unclaimed items due to the loss or destruction of the token will take place only after all people have left the club or on the next day, at the times indicated by the club staff.
15. Gdańsk University of Technology does not deposit valuables in the cloakroom and does not take responsibility for cash and valuables left in the cloakroom (including in particular: documents, electronic equipment, payment cards, jewelry, etc.)
16. Gdańsk University of Technology is not responsible for small items left in sleeves or pockets (scarves, hats, gloves, etc.)
17. These Regulations come into force on 25 October 2021.
